INVITATION FOR TENDERS

Contracts A1-3 and A1-4

Communal Production Unitary Enterprise "Brestvodokanal", hereinafter referred to as "the Purchaser", intends to use part of the proceeds of a non-refundable technical aid from the Northern Dimension Environmental Partnership (NDEP) towards the costs of Contract A1-3 "Procurement of CCTV equipment for the sewer system including a vehicle" and Contract A1-4 "Procurements of combined flushing and suction vehicle".

Communal Production Unitary Enterprise "Brestvodokanal" now invites sealed tenders from eligible tenderers for the following contracts:

Contract A1-3: The Supply Contract includes supply of CCTV and trenchless maintenance equipment for the sewer system, portable CCTV system for inspection of pipelines, CCTV equipment for inspection of wells and a vehicle where the above equipment will be installed. In addition the contract includes training of personnel and technical maintenance of the equipment.

Contract A1-4: The Supply Contract includes supply of flushing and suction vehicle and sets of flushing nozzles and heads. In addition the contract includes training to use the vehicle and flushing equipment and technical maintenance of the equipment.

Planned commissioning and completion of first training period for both contracts is 210-220 days.

Eligibility and Qualification Criteria

Eligible nationalities of tenderers and subcontractors, and eligible origins of goods and related services for Contracts A1-3 and A1-4 are specified in Section V of the Tender Dossiers (Eligible Countries).

To be qualified for the award of the Contract, tenderers must satisfy the minimum criteria set in Tender Documents, including but not limited to:

- Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- Tenderer shall have an average annual turnover as Supplier (defined as billing for Goods and Services delivered or under delivery) over the last three years of not less than 0.7 million EUR equivalent (contract A1-3) and 1 million EUR equivalent (contract A1-4);
- Experience as Supplier in at least three (3) contracts within the last five (5) years, at least one with a value of at least 0.2 million EUR equivalent (contract A1-3) and 0.35 million EUR equivalent (contract A1-4), successfully and substantially completed and similar to the proposed goods;
- Tenderer must demonstrate access to or availability of financial resources in the amount of not less than 0.2 million EUR (contract A1-3) and 0.3 million EUR (contract A1-4);

• Tenderer shall provide evidence that the Tenderer or its agent will be able to carry out the supplier's maintenance, repair and spare parts stocking and supply obligations.

The tender must be accompanied by a tender security of EUR 10 000 (contract A1-3) and EUR 15 000 (contract A1-4) in a form defined in the Tender Documents.

Tenders must be delivered to the office at the address below on or before September 5, 2017 at 10-00 (local time), after which time they will be opened in the presence of those tenderers' representatives who choose to attend.
